Comments from Members of the Public

Mr. Chuck Johnson from the Washington and Oregon Physicians for Social Responsibility shared that he received a copy of the anonymous employee letter and noted what he believed as the important issues that were raised. He looks forward to hearing how the agency will address the issues.

Chief Executive Officer Report

Mr. Mark Reddemann, Chief Executive Officer, provided comments regarding the recent employee letters, stating that senior management is taking the letters very seriously; that they are looking at processes in a couple different areas; and assured the board that senior management will correct the issues.

Chair Morrison also shared that the Executive Board is taking the letters very seriously. He shared that the decision was made the previous night, in an open session, to hire an independent investigator. The investigator will look into the allegations under the guidance of an ad hoc committee. Committee members will include Mr. Jim Moss and Ms. Linda Gott as co-chairs and Mr. Orser as an additional members.

Mr. Reddemann said he looks forward to the conclusions and recommendations

Mr. Reddemann went on to provide the CEO Report. Key highlights included: recent member visits; 2015 milestone highlights; annual report; recent announcement that Brent Ridge, VP-CFO is receiving BPA's Award for Exceptional Public Service; nuclear promise; utility working group; Olympia testimony; state legislative visits; recent CEO recognition lunches; labor contract ratifications; and high-level asset performance review.

Mr. Reddemann wrapped up by addressing several questions from the governing boards.

Ms. Lori Sanders questioned the action from the December meeting to address the CEO's delegation of authority. Mr. Reddemann recommended further discussion resulting in a bring back at a future meeting.

Chair Morrison recessed the joint meeting for lunch at 11:35 a.m.; and reconvened at 11:52 a.m.

Chief Nuclear Officer Report

Mr. Brad Sawatzke, Chief Operating Officer and Chief Nuclear Officer, presented the Chief Nuclear Officer Report. Key points included: plant status, collective radiation exposure reduction; Nuclear Regulatory Commission update; upcoming events; and Columbia Generating Station performance indicators.

Mr. Sawatzke committed to look into the training of dose champions, above and beyond the normal training.

Mr. Sawatzke also committed to improve rolling averages and year-to-date forecast on key performance indicators.

These two actions will be tracked under the Nuclear Oversight and Safety Committee commitment tracking.

Chair Morrison requested Mr. Sawatzke delay his Harvard takeaways for the next regular meeting.

The meeting adjourned at 1:33 p.m.
